

REQUEST FOR PROPOSAL (RFP): SOCIAL ENTERPRISE BUSINESS DEVELOPMENT CONSULTANT

1. PROJECT OVERVIEW

Calgary Immigrant Women's Association (CIWA) is seeking a qualified social enterprise business development consultant to support the creation of sustainable social enterprise models. Existing focus areas include employment platforms, childcare and caregiving services, and Language Venture (professional translating). The consultant will be responsible for helping CIWA surface and articulate an overall Social Enterprise Strategy and developing an enterprise model framework to be used for CIWA's social enterprise programs.

2. PROJECT OBJECTIVES

- 1. Work with CIWA stakeholders to articulate a unifying Social Enterprise Strategy.
- 2. Create a set of strategic values and guiding principles to be used for opportunity assessment.
- 3. Create a Social Enterprise Model Framework, consisting of templates and processes for:
 - a. Business modelling
 - b. Financial modelling
 - c. Organizational fit assessment
 - d. Infrastructure, technology, and budgetary requirements
- 4. Use the framework to develop social enterprise models for one or more of CIWA's current focus areas.

3. SCOPE OF WORK

3.1 Social Enterprise Strategy Development

1. Create a comprehensive strategy, aligning current and proposed social enterprise initiatives from within and new CIWA programs (i.e. Employment Synergies, Line Cook and Hospitality Training, Childcare Centre, and Language Venture). Include alignment assessment criteria, such as organizational values and guiding principles.



3.2 Social Enterprise Framework Development

- 2. Create a template for modelling existing and potential social enterprises, including:
 - Description and value proposition
 - Target audience and social beneficiaries
 - Financial model, with pro-forma projections
 - Program model, with staffing, technological, and infrastructure requirements
 - Implementation and evaluation planning

3.3 Business Plan and Model Development

- 1. Create sustainable social enterprise models for one or more of:
 - Employment platforms
 - Childcare and caregiving services
 - Language Venture (professional translating)
 - CIWA's employment bridging programs: childcare, line cook,
- 2. Develop comprehensive financial models for each venture
- 3. Identify potential revenue streams and collaborations and cost-saving opportunities
- 4. Propose strategies for scaling and long-term sustainability

3.4 Future Needs Analysis

- 1. Identify infrastructure requirements for each social enterprise
- 2. Recommend appropriate technology solutions to support operations
- 3. Develop a budget projection for the next 3-5 years

4. DELIVERABLES

- 1. Comprehensive business plans for each social enterprise model
- 2. Detailed financial models and projections
- 3. Market research report and needs assessment findings
- 4. Infrastructure and technology recommendations
- 5. Budget projections and final report with recommendations

- 2. Relevant experience in social enterprise development
- 3. Proposed methodology and innovative approaches based on close collaboration and understanding of client needs
